- The Private Medical College should provide Bank Guarantee of required amount in favour of 3. Medical Council of India, New Delhi valid for three years from a nationalized/ scheduled Bank as per MCI's norms. However, medical colleges/ institutions governed by the State Govt. are required to furnish only an undertaking to provide funds in their budget till the facilities are fully provided as per time bound programme indicated by them.
