Government of Karnataka have considered the recommendation of the Rajiv Gandhi University of Health Sciences, Bangalore and decided to issue Essentiality and Feasibility Certificate for starting of MDS Courses afresh as mentioned below for the academic year 2020-21 subject to the condition that the institution shall surrender not less than 33% of the total sanctioned seats to Government quota for the students of Karnataka State and fees fixed as per the consensual agreement that will be entered into from time to time or as per the Karnataka Professional Educational Institution (Regulation of Admission and Determination of Fee, Act, 2006 and these seats shall be allotted as per the merit and reservation policy of the State Government. The admissions / counseling for all sanctioned seats shall be made by the State Government or its agency i.e., KEA

It is certified that: -

- The applicant owns and manages a 720 bedded hospital.
- a. The applicant owns and manages a dental clinic with 216 Chairs.
- b. It is desirable to establish a Dental college in the public interest.
- c. Minimum dental out patients per day are available to begin with.
- d. The credibility and the financial status of the applicant has been verified.

It is further certified that in case the applicant fails to create infrastructure for the Dental College as per DCI norms and fresh admissions are stopped by the Central Government, the State Government shall take over the responsibility of the students already admitted in the College with the permission of the Central Government.
