





Please note that the Scholarship cannot support procurement of equipment and institutional charges. Please note that the Research has to be completed within one year, starting April 2017.

Please note that the scholarship in no way creates any contract of employment or service provision between you and INTACH, nor does it require or allow you to represent INTACH during the project, or to represent the project as being an INTACH managed or directed project.

As per your application, the potential outcome of your research is:

Analyze the materials and construction techniques of vernacular houses of Mangalore specially known as Guttu Houses.

Study the various typologies of houses with construction materials as they are slowly becoming defunct.

Document the innovative construction techniques of the Guttu Houses with special attention to their openings.

In addition to the above, INTACH hopes to receive a full report on 'To analyse and understand materials and construction techniques of vernacular houses of Mangalore specially known as Guttu Houses'. This is "housekeeping" so that we can see that the scholarship has been effectively used; it will not alter the status of the report as your intellectual property. However, we wish to clarify that INTACH shall hold all rights to publish, distribute and place the manual in our library for public access. You will be required to sign a library consent and publication consent form at the end of your research.

Also, as per the guidelines set by our selection committee, funds will be disbursed to you in three stages. First installment will be dispatched after receiving the duly filled up acceptance letter and bank details, second installment will be dispatched after receiving an interim report on your research, and the final installment will be dispatched after receiving the final report. Please note that for every installment you will have to provide original receipts to prove effective and appropriate utilization of funds. The scholarship amount is tax deductible as per Government of India norms.
