BETWEEN

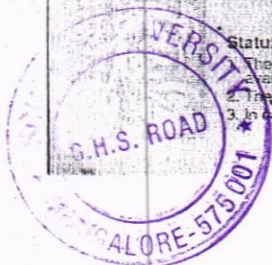

Hereafter refer to as M/s. Ramky Energy & Environment Ltd.

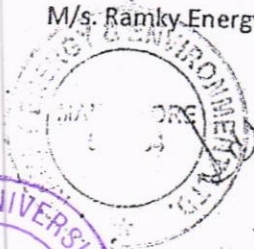
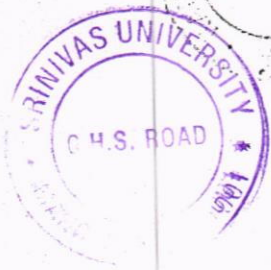

INDIA NON JUDICIAL GOVERNMENT OF KARNATAKA DEPARTMENT OF REVENUE MANGALORE

- a. M/s. Ramky Energy & Environment Ltd with approval from Karnataka State Pollution Control Board having a common treatment facility for managing Bio-Medical waste in Dakshina Kannada district at plot no 47-B, KIADB Industrial area, Karnad, Mulky, Mangaluru. The facility is having state of autoclave system along with shredder and incinerator.
- b. M/s. Srinivas Institute of Medical Science and Research Centre gives its bio-medical waste properly packed in colour coded bags (in case of amputated parts the hospital should give one letter duly signed by authorized person mentioning the patient's name, age & reason for amputation) as per pollution control board regulations for treatment and final disposal to M/s. Ramky Energy & Environment Ltd. The waste should be given at one single point by the M/s. Srinivas Institute of Medical Science and Research Centre at given time of M/s. Ramky Energy & Environment Ltd.
- c. M/s. Ramky Energy & Environment Ltd will charge a price of Rs.13200/-(Rupees Thirteen Thousand Two Hundred Only) per month for one year and there is a minimum increase 10% per annum as agreed with mutually M/s. Srinivas Institute of Medical Science and Research Centre for collection, transportation, treatment and final disposal of bio-medical waste. The price will be fixed for a period of up to 31<sup>st</sup> May 2023.
- d. M/s. Srinivas Institute of Medical Science and Research Centre during this period will not enter into any agreement with any other party or organization for the waste treatment and disposal.
- e. M/s. Srinivas Institute of Medical Science and Research Centre has 705(Seven Hundred five) number of beds. The exact number of beds will be taken from the declaration given to the state authorities.
- f. M/s. Srinivas Institute of Medical Science and Research Centre is assuring that the payment should be made through account payee cheque in favour of M/s. Ramky Energy & Environment Ltd on or before 15<sup>th</sup> of every month.
- g. M/s. Ramky Energy & Environment Ltd will collect medical waste regularly and treat the waste as per the regulations. M/s. Ramky Energy & Environment Ltd will not collect any waste that is not segregated or properly packed and also general garbage.
- h. M/s. Srinivas Institute of Medical Science and Research Centre if requested will supply the colour coded waste collection bags at a nominal rate mutually decided between M/s. Ramky Energy & Environment Ltd and hospital.

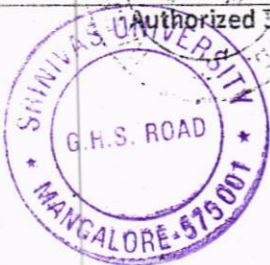


- i. M/s. Ramky Energy & Environment Ltd will issue a proof waste collection from M/s. Srinivas Institute of Medical Science and Research Centre on regular basis. This will help the individual hospital for getting compliance with the state pollution control board. The individual hospital/nursing home can take their authorization from the pollution control board by informing the board that M/s. Ramky Energy & Environment Ltd treats their waste, (the same has to be mentioned in the authorization form).
- j. In case of hospital/nursing home/clinics find any irregularities in collection waste, they can send a notice in writing to M/s. Ramky Energy & Environment Ltd for immediate action.
- k. M/s. Ramky Energy & Environment Ltd will maintain their plant in good condition all the time and ensure continuity of service on all the days without fail and get clearance from the Pollution Control Board as per regulations.
- l. This Memorandum of understanding is entered into on the express understanding that M/s. Ramky Energy & Environment Ltd will maintain and run the facilities and collect transport and treat the waste at their plant strictly in accordance with the consent of the Karnataka State Pollution Control Board and it shall be the responsibility to obtain the consent and keep the same always in force.
- m. In case of violation of any of the agreed conditions of the MOU by either side, Issue of notice may terminate this MOU three months in advance by either party for terminating their respective obligations.
- n. This Memorandum of Understanding will remain valid for a period of three years commencing from **01<sup>st</sup> June 2020 to 31<sup>st</sup> May 2023**, after which date the agreement will automatically stand terminated by the efflux of time unless extended further by mutual agreement.
- o. All disputes to this understanding are subject to the jurisdiction of the court in Mangalore only.
