In exercise of powers conferred under Sec. 23(1) of Karnataka Nurses, Midwives and Health Visitors Act of 1961 and rules there under Srinivasa University (Private University Established Under Karnataka State Act No-43 of 2013) G.H.S. Road, Mangaluru-575 001, Karnataka State, India was inspected and found feasible to start GNM Nursing Programme with an enhancement from 60 to 100 Seats (Sixty to Hundred), BSc . Nursing Programme with an enhancement from 60 to 100 Seats (Sixty to Hundred), PBBSc . Nursing Programme with an enhancement from 30 to 60 Seats (Thirty to Sixty) & also accorded provisional approval from the academic year 2020-21 subject to the following terms and conditions:-

1) The Physical and clinical facilities and staff should be as per Indian Nursing Council and Karnataka Nursing Council syllabus and regulations and the deficiencies if any pointed out by the inspectors has to be rectified immediately before admitting the students. Copy of the deficiency report is enclosed herewith for immediate action.

2) The Syllabus and other rules and regulations stipulated by Indian REEM Nursing Council and Karnataka Nursing Council from time to time has to the followed

3) Admission is once in a year, Excess intake of admission leads to cancellation of approval/recognition of the college.

4) The provisional Approval has to be renewed immediately after the **express COPV** every academic year on payment fixed fee as required U/s. 49 (c)of bye-law of KSNC 1991.

5) The management of nursing college shall furnish reports, returns, fees and other information to council as and when asked for and all the conditions in the

Government Order should strictly be followed.

6) Proper security has to be provided to the students hostels. If any malpractice is reported, the provisional recognition will be cancelled without notice.

7) Acquitance roll, Attendance Register of staff, students Admission Register, Syllabus and Master Rotation Plan details of clinical facilities available has to be furnished at the time of INC/KNC inspection.

8) Violation of any rules by the institutions/college below the required standard of INC and KNC amounts to withdrawal of recognition.

9) Institution should obtain suitability U/s. 13 of the INC Act from the Indian Nursing Council, New Delhi and intake fixed by the INC from time to time should be adhered
