# Preamble

WHEREAS the Srinivas University and the Ecole Nationale Supérieure Mines Télécom Lille Douai (IMT Lille Douai), higher school of Engineering (hereinafter "the parties" / "institutions"), inspired by the extensive possibilities offered by international co-operation, recognise the need to develop and nurture new partnerships and to share human and material resources, with the aim of promoting international understanding, contributing to the pool of global knowledge and advancing the development of our respective countries and the world.\*

AND WHEREAS in the spirit of this challenge and responsibility, the parties acknowledge the similarities in the scholarly pursuits of the institutions and desire to promote inter-institutional co-operation, scientific and cultural exchange, and mutual understanding and respect between the citizens of India and those of France;

AND WHEREAS the parties therefore join in the following Agreement:

## Article 1

- 1.1. The two Institutions shall establish and encourage mutually beneficial scientific, technological, educational and other relations based on some (but not necessarily all) of the following activities as outlined according to Article 2 below:
  - 1.1.1. Exchange of academic staff members for the purpose of research, teaching and the presentation of special courses in their fields of specialisation.
  - 1.1.2. Establishment of joint research programs.
  - 1.1.3. Supervision of joint Master's and Doctoral degrees.
  - 1.1.4. Exchange of students (undergraduate and/or postgraduate) in respect of specific research projects or courses of interest and importance.
  - 1.1.5. Exchange of scientific and educational literature produced by either or both of the parties, as well as the exchange of material on relevant and topical research undertaken by researchers of both institutions.
  - 1.1.6. Organisation of conferences, seminars and symposia of mutual interest to the institutions.

# Article 2

- 2.1. In each case, the theme for a joint activity, the conditions for the ownership of any Intellectual Property, arrangements for a visit, exchange and other forms of co-operation shall be determined collaboratively by the management and scholars of the institutions and will be the subject of a separate, signed agreement (to be appended to this agreement).
- 2.2 The number of members of staff to participate in a visit or exchange program, their sojourn and conditions of service shall be negotiated in each case, with due consideration to the capabilities and needs of the individuals and the institutions concerned.

- 2.3 The parties agree that the aforesaid supervision of joint Master's and Doctoral degrees shall be managed in terms of a separate signed agreement per student to be negotiated in good faith as an addendum to this agreement.
- 2.4 Where student exchange is intended as part of the agreement, the number of students to participate in an exchange program, their sojourn and conditions of study shall be negotiated in each case, with due consideration to the capabilities and needs of the individuals and the institutions concerned. These exchanges may be administered on a reciprocal basis with a number of reciprocal visits per semester per institution agreed upon between the parties. (Addendum to be appended to this agreement).
- 2.5 Where student or staff exchanges are part of the agreement, current legislation and policies of *India* will to be adhered to.
- 2.6 Unless otherwise agreed upon between the parties in respect of specific exchange students:
  - 2.6.1 an exchange student will be liable for the payment of tuition fees at the home institution;
  - 2.6.2 the host institution shall be responsible for funding that will cover the application and tuition fees related to the student's agreed program of study; however, some additional fees may apply;
  - 2.6.3 an exchange student will be responsible for the cost related to accommodation, travel, books, subsistence, medical expenses, medical insurance and study fees for study not included in the agreed program of study. The parties shall, however, endeavour to assist exchange students and staff to obtain adequate and reasonable accommodation...
  - 2.6.4 Access to facilities such as libraries and the Internet will be made available for academic and research purposes at the host institution.

- 2.7 Current legislation and policies of the *India* are incorporated into the Policies of the Srinivas University and have to be adhered to. Medical aid cover from a medical scheme registered with the Council for Medical Schemes in *India* must be acquired and is compulsory for all international students visiting the country. International or *India* medical insurance is not acceptable. Even in the event that students do obtain medical insurance for traveling purposes, the medical aid cover as stipulated above must still be obtained for registration purposes at the Srinivas University International students shall take up membership of a medical aid scheme before entering the country. Students from the IMT Lille Douai shall therefore, via their International Affairs and Academic Partnerships and prior to their visit, communicate with the Department Research and Innovation Support: International Students Division at the Srinivas University in this regard.
- 2.8 Matters such as course information, accommodation, additional fees, and the appropriate permits should be addressed well in advance.
- 2.9 It is compulsory for exchange students whose language of tuition is not through the medium of English to provide sufficient proof of their English language proficiency.

## Article 3

3.1 Both parties accept that, in case of joint projects which require additional funding not included as part of this agreement, that financial arrangements shall be negotiated in each case and continuation of said projects shall be dependent on the availability of funds.

## Article 4

4.1 This Agreement represents the total Agreement between the parties.

Memorandum of Co-operation between Srinivas University and IMT Lille Douai

4.2 The parties, or their authorised substitutes, shall evaluate this Agreement regularly to decide on changes or additions thereto, which will not be of any force or effect unless in writing and signed by the representatives of both parties.

# Article 5

This Agreement shall come into effect when the authorised representatives of both parties have signed it and shall be valid for a period of 5 years. Either party may however, withdraw from the Agreement by giving written notice before 30 June of any year of its intention to withdraw with effect from the beginning of the next calendar year. Should a project or program not yet be completed, the incumbent will be allowed to finish it.

# Article 6

6.1 The parties choose for purposes of this Agreement as their *domicilium citandi et executandi*, the following addresses:

- 6.2 A party may at any time change its *domicilium* by giving notice in writing, provided that the new *domicilium* consists of, or includes a physical address at which process can be served.
- 6.3 The signatories appoint the Dr Praveen B M, *Department of Chemistry* (for Srinivas University) and the International Affairs and Academic Partnerships as co-coordinators for the purpose of this Agreement.

# MEMORANDUM OF UNDERSTANDING

In order to promote co-operation between Research & Development, Jain Institute of Technology, Karnataka, India and Srinivas University, Karnataka India, the two institutions agree as follows: -

WHEREAS, Srinivas University is an Institution in the State of Karnataka, established and governed by A. Shama Rao Foundation (ASF). Srinivas University was established in and situated in Mangalore, Karnataka. It falls under the flagship of Srinivas Group of Colleges, which has 8 colleges

The campus is fully equipped with sufficient classrooms & infrastructure to handle the additional responsibilities required under this MOU.

WHEREAS Airvantix, Bangalore, Karnataka is a registered Private Limited Company and has developed expertise in design & delivery of innovative, industry relevant job-oriented Diploma, Certificate and Undergraduate programs through Universities, Autonomous Institutions and Colleges in the field of Aviation, run by professionals with decades of experience in the field.

Airvantix has the expertise, curriculum, course-ware and study material and has approached the University for setting up the education programs within their campus. The University has agreed to Airvantix, to provide suitable & sufficient class rooms and other allied infrastructure & faculty to impart the educational programs developed & designed by Airvantix, and which are approved by the Board of Studies & Academic Council of Srinivas University, to prospective students at their campus in Pandeshwar, Mangalore.

1. Proposed Programs

1.1. Proposed Programs listed in Annexure 4.

1.2. Both parties hereby have agreed to associate together, and the parties have also agreed on the terms for cooperation as given in the succeeding paragraphs.

# THE FOLLOWING OUTLINES THE RESPONSIBILITIES OF BOTH THE PARTIES

### 2. Responsibilities of FIRST PARTY (Srinivas University)

2.1. The First Party shall be responsible for providing all infrastructure facilities necessary for the conduct of the programs, (program wise infrastructure requirement given in **Annexure 1**). Such facilities will be as mutually agreed upon and include classrooms with projectors, library, computer labs equipped with computer systems, IT devices (Hardware and software required for specific courses) and access to other support facilities including printers, scanners and multimedia equipment, facsimile and internet facilities, faculty staff room, cabins for course coordinators, admission process administrators and counsellor's room, rest rooms, storage facility and such other facilities that may be necessary for promotion & delivery of the programs.

2.4. The First Party shall issue identity cards to all admitted students.

2.5. The First Party shall share prescribed percentage of fees as mentioned in clause number 6, from the total program fees received from the enrolled students with the Second Party.

2.6. The First Party shall provide the Second Party with detailed operational guidelines (written / printed) arising out of this agreement to be followed by the Second Party for the implementation of the programs.

2.7. The First Party shall bear the basic operational charges such as upkeep of class rooms, electricity, water charges and any tax liabilities etc.

2.8. The First Party shall keep its website updated on information on the programs offered jointly with the Second Party from time to time. Such information shall be updated on a regular basis to reflect any changes in the programs offered.

2.9. The First Party shall appoint / depute a responsible person as co-ordinator to ensure proper functioning of the unit set up to conduct the program covered under this MOU. The coordinator will also serve as one-point contact for the Second Party as far as working of the said unit is concerned.

2.10. The staff of the First Party shall not tamper with the course materials either by way of modification, servicing or otherwise manipulating the mechanism in any way or for any reason whatsoever. The appointment under this agreement does not entitle the First Party, to any right or interest over the intellectual property of the Second Party. It shall be the responsibility of the First Party, to ensure that none of its employee's agents or representatives causes any infringement on the rights of the Second Party.

2.11. The registered copyright owners of the course materials have suitable agreement with the Second Party and the operation of this Agreement shall not operate to confer on the First Party, any right, title or interest over the said material, and any supplements and

additional materials that may be supplied to the First Party, the said course materials shall be provided to only the students who are duly registered in the course/subject.

2.12. The First Party with the assistance of the Second Party shall prepare publicity materials of the programs to be launched and display them in different online media after ensuring that they are in conformity with the program. Such publicity materials should display the name of the **First Party and the Second Party as a knowledge partner and their logo.** The cost for such publication would be borne by the First Party.

# 3. Responsibilities of the SECOND PARTY (Airvantix)

3.1. The Second Party will be responsible for limited marketing and counselling of prospective students, program design, development, course content, course execution and course up gradation in consultation with the First Party and approved by the Board of Studies, Academic Council and other bodies as per the University's existing rules.

3.2. The Second Party will be responsible for faculty recruitment for specific units along with the First Party as per the norms of the University. The appointment of such faculty shall be governed by terms set out in **Annexure 3** (for financial terms)

3.3. The academic delivery will be controlled and monitored by the Second Party as per the guidelines of the First Party and the faculty and guest lecturers shall be bound by the administrative directions, control and policy of the First Party.

3.4. The Second Party shall provide faculty for specific units with suitable training, education, skills, experience and other qualifications to deliver the programs and shall be responsible for the costs of training of such faculty.

3.5. The Second Party shall be responsible for providing appropriate learning materials to students for the specified units.

3.6. The Second Party shall follow the course curriculum approved by the Board of Studies (BOS) and Academic Council instituted by the First Party.

3.7. The Second Party shall be responsible for completion of both theory and practical training sessions for the specified units of the course within the prescribed period for which admissions have been made.

3.8. The Second Party shall provide all possible assistance to the First Party for the conduct of the examinations.

3.9. The Second Party shall assist in internal assessment of students, evaluate assignments and project reports and assess students through the faculty under the given guide lines of the First Party and maintain appropriate records of the same. All expenses towards the same will borne by the Second Party.

3.10. The Second Party shall be responsible for providing assistance towards placement opportunities for students who successfully complete the program.

3.11. The Second Party shall be responsible to provide industry-institution interaction and talk by industry guest speakers. All expenses towards organizing such sessions will be borne by the Second Party.

3.12. The Second Party shall ensure adherence to quality standards prescribed by the First Party and follow all the norms & procedures as set by the First Party.

3.13. The Second Party shall keep its website continually updated regarding the programs offered under this MOU.

3.14. The Second Party Shall be responsible for the course material development in coordination and in line with the requirements of the First party.

3.15. The Second Party realizes that the students being admitted under this Agreement will be regular and bonafide students of the First Party and the Second Party is therefore obliged to ensure that no action/inaction on its behalf should cause a loss of reputation or embarrassment to the First Party.

### 4. JOINT RESPONSIBILITIES:

### 4.1 MARKETING RESPONSIBILITIES AND EXPENDITURE:

4.1.1. The cost of all admission notifications and advertisements related to the programs under this collaboration if released will be borne by the First Party. The Second party can promote the specific programs in the online media and all such notifications and advertisement shall be in conformity with the Srinivas University Standards and such costs will be borne by the Second party.

4.1.2. The First Party shall include the programs launched under this MOU in its regular Advertisements as and when required. If any such advertisements are released, the cost of such Advertisement will be borne by the First Party.

4.1.3. The Second party will make all efforts in spreading awareness through any online or direct marketing campaigns for marketing of the programs listed in **Annexure 4** in conformity with the First party.

# 5. FEE STRUCTURE:

5.1. The Program fee per student per year / semester will be prescribed jointly by the First Party and the Second Party and will be mentioned in Annexure 5.

# 6. **REVENUE SHARE & PAYMENTS: Revenue will be shared in the following ratio:**

6.1. For the infrastructure & other services rendered, Srinivas University will get  $37 \cdot 5 - \%$  of the Total Program fees (Tuition fee and Annual fee). Any other fee including Registration fee, Application fee and Exam fees will not be included in the revenue sharing.

6.2. For the services rendered and as detailed in this MoU, the Second party will share 69-5 % of the Total program fees (Tuition fee & Annual fee).

6.3. All expenses towards the Program marketing, Student acquisition and program delivery will be the scope of the Second party. Expenses that of delivery of specific units as agreed in this MoU and the placement assistance services & specific training, if any will be the scope of the Second party.

### 7. PAYMENTS:

7.1. The representative of the Second party can counsel prospective students directly and allowed to collect the fee from the students (in form of DD or Cheque only in favour of Srinivas University) and deposit the same with the Accounts Department of the University at the time of admission of the candidate. For remaining semester fees, the standard process of fees submissions will be followed by the student as defined by the University.

7.2. Any refunds that may accrue to students who withdraw from a course after registration would be as per the refund rules of the University. Any amount that is retained from such fees paid by the prospective student shall be shared between the two parties as per the agreed sharing ratio.

7.3. The Share <u>Collection</u> to be paid to the Second party as per the below timeline:-

7.3.1. The Share of 5% of the total fees (Tuition fee and Annual fee) collected to be paid to the Second party within 15 days of collection during the academic year in which the admission is made for the Bachelors program and within one month of the collection of the prescribed fee for other Diploma and Certificate programs.

8. ADMISSION CYCLE:

8.1. Admission cycle will be as per the University norms. Airvantix marketing team will interact with the University and finalize the admission time lines.

9. **ANNEXURE No 1, 2, 3, 4 and 5** on program wise infrastructure requirement, eligibility criteria for admission, faculty appointment and payment, list of marketing programs, and fee structure, as appended to this document will be considered as part of the MOU.

#### **10. EVALUATION:**

10.1. Examinations shall be as per the ordinance of the University. The examination fee will be as per the standard University norms. The First party will share the information about such notifications related to the exams with the Second Party. The Second party is expected to evaluate such specified units as allotted under this MoU and return the same to the First party with utmost confidentiality.

# 11. DURATION OF THE AGREEMENT:

11.1. This Agreement shall remain valid and binding upon both the parties for a period of **3 Academic Years or Intakes**, effective from the date on which it is signed. It may however be renewed if both parties are agreeable to the same. In the event of renewal, apart from signing of a fresh agreement, revised financial terms may be agreed to on mutual consent.

11.2. If in any case, either Party decides against further renewal of this Agreement, after expiry of this Agreement it shall be the responsibility of both, the First Party and the Second Party to see that the students already studying (at the time of expiry of the Agreement) shall continue and complete the course as per the provisions of this Agreement and for this purpose, the Agreement shall be operative.

# 12. TERMINATION OF AGREEMENT:

12.1. The parties shall be entitled to terminate this Agreement by mutual consent.

12.2. Either party shall be entitled to terminate this Agreement in case of material breach by either parties of any of its obligations or representations and warranties under this Agreement which remains un-remedied for a period of 45 working days. Additionally, either party may terminate the Agreement by giving one year of notice if the performance is not found to be satisfactory. In case of termination of the Agreement, both parties shall execute their responsibilities as agreed in clause 11.2.

### 13. ARBITRATION:

13.1. Any dispute arising with regard to any aspect of this Agreement shall be settled through mutual consultation and by written consent by the parties to the Agreement. In

13.2. The term First Party and Second Party afore mentioned unless repugnant to the context shall mean and include their successors in office, authorized representatives and assignees.

#### 14. JURISDICTION:

14.1. In the event of any dispute between the parties, no court case shall be preferred by either party until Arbitration has been resorted to and proved unfruitful, and shall be under the jurisdiction of the court in Bangalore.

#### 15. FORCE MAJEURE:

15.1. Notwithstanding herein before mentioned, this agreement shall be deemed to have been suspended for the period during which and to the extent to which either Party hereto is prevented, hindered or delayed from performing any part of this contract by reason and any cause or circumstances of Force Majeure and which cannot be overcome by diligence and such affected party shall be excused from such performance to the extent that it was necessarily, of events, such a happening or event shall include, but not be limited to Acts of God, any restriction, regulation, order, acts of omission or operation by any central. State, Local, Municipal or any other authority concerned, wars, fire, explosion etc. The Parties hereto recognize that the policy in relation to prohibition of any Central, State, Local, Municipal or any other authority concerned has a vital bearing on the ability of either of the Parties hereto in fulfilment of its obligations mentioned in the Agreement.

15.2. Neither Party shall be liable to compensate any loss, damage or delay caused by war, riots, agitation, lock-outs, labour trouble or infrastructural deficiency, commotion,

### 16. AMENDMENT TO THE MOU:

### 17. NOTICES:

17.1. Any notice or other communication under or in connection with this Agreement shall be in writing, in English and shall be transmitted by facsimile, e-mail or recognized courier service addressed to the intended recipients under this Agreement.

#### **18. ENTIRE AGREEMENT:**

18.1. This Agreement constitutes the entire understanding and agreement between the Parties with respect to the subject matter and supersedes any prior oral or written agreements, representation, arrangements, understandings or communication. Any amendment hereto will be in writing and signed by both the parties.

5. On the day of admissions, seating space will be provided for counselling for IMAGINXP<sup>™</sup> along with any other support required for counselling of students.

6. Required content/books/journal/publications will be added to the library as suggested by IMAGINXP<sup>™</sup>.

7. Support from examination and academics department for smooth running of the course.

8. All stationery and class material required for smooth running of the course

9. Any other special requirement related to infrastructure which is recommended by IMAGINXP<sup>™</sup> for the successful delivery of the program as per prevailing norms of SRINIVAS UNIVERSITY

10. SRINIVAS UNIVERSITY shall be responsible for lodging and boarding of IMAGINXP<sup>™</sup> trainers and admission staff stationed at SRINIVAS UNIVERSITY at nominal charges.

Based on this test students will be awarded an ImaginXP<sup>™</sup> certificate in UX design with a DQ (Design Quotient) score which is an industry accepted credit score. SRINIVAS UNIVERSITY will ensure this is mandatory for all students studying B.DES-UX / MDES-UX.

f) Shall keep its website updated on the information pertaining to program offered by IMAGINXP<sup>™</sup> with a mention of IMAGINXP<sup>™</sup> as knowledge partner. IMAGINXP<sup>™</sup> logo will be used in all marketing collateral and curriculum material in association with the BDES-UX / MDES-UX course including – website, print ads, TVC, Radio ads, admissions material, prospective, course brochure as per IMAGINXP<sup>™</sup> brand guidelines.

g) The nomenclature of the '*BDES-UX* / MDES-UX in collaboration with ImaginXP<sup>™</sup> 'will be used by SRINIVAS UNIVERSITY in all material wherever the course name is published.

l) SRINIVAS UNIVERSITY will be responsible for maintaining exam data and managing backlog exams for subjects taught by university faculty as per university guidelines

m)The guidelines will be jointly made and will be followed by both the parties for delivery of subjects in SRINIVAS UNIVERSITY in letter and spirit.

# 4.2 RESPONSIBILITIES OF IMAGINXP™

a) IMAGINXP<sup>™</sup> will be responsible for the admissions and complete academic conduct of the course.

b) IMAGINXP<sup>™</sup> will appoint a single point of contact (Herein after referred to as "SPOC") as the academic course coordinator for the BDES-UX / MDES-UX program. The SPOC will be responsible for day to day operations and coordination for running of the course. In order to have better coordination and proper administrative control over the students:

g) The program of study will be designed as per minimum norms and standards of UGC and other statutory body and both parties would ensure that the course isfully complied. Further IMAGINXP<sup>TM</sup> would ensure that the students are exposed to the latest software and products, will invite top Faculty/industry expert for Guest Lectures, will arrange site visits and industry visits for the students the cost of which shall be separately collected from the students. The profiles of the guest lectures would be approved by the University. For organizing these events, IMAGINXP<sup>TM</sup> would not be paid anything extra and the same would be part of their scope of services. Further IMAGINXP<sup>TM</sup> would ensure that the course and the program of study is of national and international standards and should be able to compete with any other similar program being offered in the courty.

h) Futuristic- Any modifications, innovations, improvisation, tests,etc in this program which IMAGINXP<sup>™</sup> devises in due course of time will automatically be covered at SRINIVAS UNIVERSITY without any extra cost. Further IMAGINXP<sup>™</sup> would ensure that it would not offer better technical terms or course structure for BDES-UX/ MDES-UX to any of its partner Institute or Centre in India. If SRINIVAS UNIVERSITY about the same, it would be considered as Breach of Contract for BDES-UX course.

i) Shall follow the course curriculum approved by the Board of Studies (BOS) of SRINIVAS UNIVERSITY.

j) Will provide a member to attend BOS meetings. Remuneration if any for attending any meetings will be as per the norms of SRINIVAS UNIVERSITY.

k) Project reports submitted by the students as partial fulfilment of Bachelor's Degree shall be the property of SRINIVAS UNIVERSITY.SRINIVAS UNIVERSITY agrees to allow IMAGINXP<sup>™</sup> to use the student projects of BDES-UX / MDES-UX for academic and promotional purposes. However, SRINIVAS UNIVERSITY reserves the right to amend/withdraw this clause, in case, SRINIVAS UNIVERSITY feels that same is not in the Interest of Students or SRINIVAS UNIVERSITY.

 Will be responsible for setting question papers, evaluation of exam paper and conducting jury for the subjects taught by IMAGINXP<sup>™</sup> faculties as per Section 4.3 of this proposal. Question papers setting must be as per Standards and Guidelines laid down by the University.

m)All evaluations by IMAGINXP<sup>™</sup> must be in the SRINIVAS UNIVERSITY campus only and all records including Question Papers and Answer Booklets to be maintained on Campus.

n) Assessments & continuous evaluation will be conducted by IMAGINXP<sup>™</sup> faculty as per the existing policy of the university or as per changed Guidelines of University from time to time.

o) IMAGINXP<sup>™</sup> will be responsible for managing backlog exams for subjects taught by IMAGINXP<sup>™</sup> faculty as per university guidelines.

p) Shall provide support in projects, internships and placements.

q) Shall provide each eligible student with 3 chances to appear for an interview for final placement in companies of National/International good repute. IMAGINXP<sup>™</sup> will ensure that the salaries provided by these companies is as per industry norms. The eligibility for placement will be as per SRINIVAS UNIVERSITY.

Such publicity should prominently display the IMAGINXP<sup>™</sup> logo and such advertisement materials must be published only after joint approval of SRINIVAS UNIVERSITY AND IMAGINXP<sup>™</sup>

s) It is mandatory for all faculty members of IMAGINXP<sup>™</sup> to follow norms and disciplinary rules of SRINIVAS UNIVERSITY.

t) All curriculum under the BDES-UX course will be compliant with UGC norms and guidelines.

d) IMAGINXP<sup>™</sup> will be responsible for admission, training and mentoring of SRINIVAS UNIVERSITY admissions and counselling teams on the BDES-UX/ MDES-UX programs and career opportunities after course completion.

e) In no event shall a Party publicize or make any press releases in connection with this MoU or the services provided hereunder without the prior written approval of the other Party. However, either party is entitled to use the other as a reference, including displaying their trademark in marketing materials.

f) IMAGINXP<sup>™</sup> shall only use the context of this MOU/Agreement/name and logo of SRINIVAS UNIVERSITY, online or otherwise or for referral purpose only after the prior approval by the SRINIVAS UNIVERSITY.

#### 8 REVENUE SHARE AND PAYMENTS

d) The revenue share of IMAGINXP<sup>™</sup> will be 62.5% of the total fee collected.

### 8.2 PAYMENT TERMS

a) These rates are all inclusive of taxes.

#### 9. Other related Points:

1. Executive Body -There will be a principal executive body that will ensure implementation of the content of this MOU and also provide clarity incase any new issue arises or any point is not covered in this MOU,the decision of this body would be final and binding. Incase the members of IMAGINXP<sup>™</sup> do not agree to any point, decision of the Vice Chancellor would be final and binding. For any matter of utmost importance the representative of IMAGINXP<sup>™</sup> can represent to Chairman, BOG of SRINIVAS UNIVERSITY. Further wherever there is change in any policy matter, financial matter, change in load distribution the recommendation of this body along with of respective statutory bodies would be forwarded to the Chairman, BOG, SRINIVAS UNIVERSITY for final approval.

This body should atleast meet twice a year. The constitution would be as follows-

#### **10CONFIDENTIALITY**

a) Parties shall not disclose each other's Confidential Information to any third party without the prior consent of the disclosing Party. Parties shall not use each other's Confidential Information for any purposes other than for which such Confidential Information was disclosed.

3. has been, is now, or later is furnished to third parties generally by the Party disclosing such Confidential Information, if such disclosure is, or has been, made to third parties generally without similar restriction, duty or limitation of use;

4. was known to the Party receiving such Confidential Information prior to the date it received such Confidential Information from the Party disclosing the Confidential Information; or,

5. has been, is now, or later is independently developed by the Party receiving such Confidential Information without use of or resort to such Confidential Information, and can be so proven by written records.

### **11INTELECTUAL PROPERTY RIGHTS**

Intellectual Property that belongs to IMAGINXP<sup>™</sup> will continue to be the in the sole ownership of IMAGINXP<sup>™</sup>. No rights of any kind whatsoever in any invention, copyright, trade secret, or any other form of intellectual property (collectively defined as "IP") are granted or transferred under this MoU. Any IP exchanged pursuant to this MoU shall be governed by the terms of a separate written agreement between the parties.

#### 12NON-SOLICITATION

SRINIVAS UNIVERSITY shall not solicit, employ or attempt to employ or offer any employment or other form of services directly or indirectly either by itself or through its associates to any of the personnel of IMAGINXP<sup>™</sup> who worked for the SRINIVAS UNIVERSITY under this MoU without the prior written consent of IMAGINXP<sup>™</sup>.

#### **13INDEMNITY**

Each Party agrees to indemnify, defend and hold entirely harmless the other Party from and against any claim, demand, cause of action, judgment, loss, liability, cost or other expense whatsoever, including without limitation, attorneys' fees (each such claim, demand, cause of action, judgment, ss, liability, cost or other expense is referred to herein individually as a "Loss" and collectively as "Losses"), which an Indemnity may suffer, sustain, incur or otherwise become subject to as a result of the use.

#### **14LIABILITY**

a) The Parties will not be liable for injuries or damages to persons or property resulting from any cause whatsoever, with the exception of bodily injuries, death or tangible property damage caused by such Party's gross negligence or wilful misconduct.

b) In no event shall the Parties be liable to each other for any damages resulting from loss of data, loss of use or loss of revenue and each Party further disclaim any and all liability for indirect, incidental, special, consequential, punitive or other similar damages.

#### 15 JURISDICTION

In the event of any disputes between the parties only the courts in Mangalore/Pune shall have exclusive jurisdiction. But no court case shall be preferred by either party until Arbitration has been resorted to and proved unfruitful.

### **16TERMINATION**

Either Party shall have the right to terminate the agreement in the event of violation of any of the conditions by giving **six months'** notice. In such an event, students already admitted in the course shall be enabled to complete their course of study and appear for the relevant examinations. The obligations of both the parties pertaining to the discharge of their responsibilities towards the completion of the course for students already admitted will continue to be in force during such period irrespective of termination of the Agreement. The validity of this agreement is initially 5 years and may be extended based on mutual consent.

### **17AMMENDMENT**

During the operation of the MOU, circumstances may arise which may call for alteration in the MOU, which shall be mutually discussed and agreed upon in writing and shall form the part and parcel of the original MOU.

#### Memorandum of Understanding (MoU) for Shodhganga/Shodhgangotri

(A Repository of Theses and Dissertations submitted to the Universities in India)

This Memorandum of Understanding (MoU) is made and entered into on 30 (Day) 11 (Month) 2018 (Year) between the INFLIBNET Centre, an IUC of University Grants Commission located at Gandhinagar, hereinafter referred to as "INFLIBNET" and <u>Srinivas University</u> (University / Deemed University / Inter-University Centre), here in after referred to as the 'University'.

WHEREAS, INFLIBNET Centre, an Inter-university Centre of the University Grants Commission, as its mandate, promotes open access to scholarly content generated in universities. The Centre has computers, network, software infrastructure and technical know-how required for hosting electronic versions of theses and dissertations in open access with interface to search, retrieve and access these content.

Srinivas University / Deemed University / Inter WHEREAS University Centre) has agreed to take part in the process of digitisation of old theses and dissertations (not available in computerized machine-readable format) and building-up of digital repository and to promote, share and host its ETD in 'Shodhganga: A reservoir of Indian theses submitted to the Universities in India' and other universities in open access. 'Shodhganga' is a name coined by INFLIBNET Centre for refering to the respository of Indian Electronic Theses and Dissertations. The word "Shodh" originates from Sanskrit and stands for research and discovery. The 'Ganga' is the holiest, longest and largest river in Indian subcontinent which has held heart of its people captive and drawn millions of people to its banks since the dawn of history. The Ganga is the symbol of India's age-long culture and civilization, ever changing, ever flowing, ever loved and revered by its people. "Shodhganga", a repository of theses and dissertations submitted to Indian universities, is expected to keep growing to a formidable size as more and more researchers from India submit their research works to this ever growing reservoir. Under the initiative called "ShodhGangotri", research scholars / research supervisors in universities are requested to deposit electronic version of approved synopsis submitted by research scholars to the universities for registering themselves for the Ph.D programme.

This Memorandum of Understanding (MoU) defines responsibilities, liabilities and commitments of the institutions involved to ensure proper system implementation, to meet the objectives pertaining to submission and access to Electronic Theses and Dissertations as envisaged by the UGC vide its Notification (Minimum Standards & Procedure for Award of M.Phil/Ph.D Degree), Regulation, 2009 dated 1st June, 2009.

NOW, THEREFORE, in consideration of the mutual agreements herein contained, INFLIBNET and the University agree to the following terms and conditions:

#### I. INFLIBNET Centre

 Provide access to ETD hosting server(s) at the INFLIBNET Centre 'Shodhganga'/'Shodhgangotri' to the University with accompanied software interface enabling University / its student to create metadata and upload their theses and dissertations in ETD repositories designed for this purpose. The INFLIBNET will take the responsibility of keeping the data intact and usable, keep back-up of the data so as to avoid its loss. The INFLIBNET will deploy tools and techniques of digital preservation to ensure continuing access to scholarly content in digital formats and to protect them from media failure, physical loss and obsolescence.

- Recommend to the UGC to extend financial assistance to the Universities under Sections 12(B) and 2(f) of UGC Act for digitization of theses and dissertations not available in computerized machine-readable format and / or for procurement and installation of a suitable computer system / infrastructure for creation of ETDs.
- Provide configuration of system, specifications and technical guidance to the University for procurement of computer hardware and related systems for setting-up of ETDs.
- 4. Provide guidelines, technical standards and specifications for digitization of Ph.D. theses submitted to the university in past and for theses not available in computerized machine-readable format.
- Impart training to at least one person from the university (from library field and / or from computer field) in creation, updation and computerized operation of digital repositories of ETDs especially on 'Shodhganga'.
- 6. Extend access to an anti-plagiarism software or provide services to evaluate theses for possible plagiarism and submit a report to the concerned university.
- The INFLIBNET may refuse to host any material deemed by the INFLIBNET to be controversial in nature or is in violation of copyright act.
- This right of refusal will not relieve the University / Ph.D. scholar of liability, both to INFLIBNET and to the public, for matter contained in the theses that may be libelous or actionable and to both INFLIBNET and copyright owners for copyright infringement by the Ph.D. Scholar.
- 9. The INFLIBNET Centre will not be responsible for i) errors, omissions, inaccuracies and quality of content or misinformation or for any damages caused to the user or any third party from the use of content provided in the theses; ii) safety and archiving of loaded content in cases of "force majeure" including natural calamities; and iii) printed version of theses.
- 10. INFLIBNET Centre will recommend or provide access to plagiarism software which university may use to detect plagiarism before awarding the degree.

11. The INFLIBNET Centre replicates the content of theses and dissertations on different server and other auxiliary storage media. However, the INFLIBNET Centre does not take the responsibility for the archiving or backing-up of loaded content. The universities, therefore, should also keep a back-up of their theses and dissertations.

12. INFLIBNET Centre also maintains a repository called "Shodhgangotri" for hosting the approved synopses of research topic submitted to the universities by the students for registering themselves under the doctoral programme. Research students/their supervisors are encouraged to submit approved synopses/research proposals and register their priority on a research proposal through the repository.

#### II. The University

- The University would grant non-exclusive worldwide license to the INFLIBNET Centre for hosting and distributing their theses in digital format in 'Shodhganga'/ 'Shodhgangotri' or any other server designated for this purpose.
- The University / its researcher scholars agree to host / upload a computerized machine-readable file in mutually agreed format of all theses on to the 'Shodhganga'/'Shodhgangotri' server at the INFLIBNET.
- The University will not hold INFLIBNET Centre responsible for any errors and omissions contained in the original theses.
- 4. The University commits to digitize theses and dissertations and their bibliographic records submitted to the university and provide necessary infrastructure including manpower support for operation of ETDs.
- Commits to utilize the assistance provided by the UGC on recommendation of the INFLIBNET for implementation of ETDs including their digitization.
- 6. Deputes at least one person from the university (from library field or from computer field) for undergoing training on implementation of ETD organized by the INFLIBNET and ensure that the person trained by INFLIBNET on ETD is / are deployed for the same job.
- Arranges to provide training to research scholars or users of its library and staff of colleges affiliated to University in creation of electronic version of theses and their deposition in the ETDs.
- Ensures use of standard software and metadata schema suggested / provided by the INFLIBNET for setting-up / development / operation of its ETDs .
- 9. Creates bibliographic records of all theses and dissertations submitted to the university in standard bibliographic formats prescribed by the INFLIBNET Centre from time-to-time and contributes these records for inclusion in the INFLIBNET's Union Catalogue (IndCat).
- 10. Commits to sharing of library ETD resources / databases with the INFLIBNET Centre as well as with other universities.

- 11. The University would agree to host their ETDs in the digital repositories 'Shodhganga or other servers' set-up at the INFLIBNET Centre, and grant nonexclusive licence to the Centre to make electronic version of theses in full-text (theses that are born digital as well as those that are digitized using scanners / digital cameras) accessible through open access ETD.
- 12. The University shall not use electronic version of theses digitized using funds given by the UGC for any commercial purposes. #### III. Termination

Both, the Parties, will have rights to terminate the MoU at any time in case of breach of obligations and terms and conditions of the MoU. This MoU signed hereunder may be terminated by either party at anytime upon ninety (90) days prior written notice. Upon termination of this Agreement, the INFLIBNET / University will stop hosting their theses immediately while keeping the theses already deposited by the University in its archives for its users. The University shall stop using the INFLIBNET's ETD facilities and databases and return any software / hardware or digitized content provided by or through the INFLIBNET, back to INFLIBNET within the 3 months notice period.

This document constitutes an agreement between XLANZ India Private Ltd, (henceforth called the 'Company') a private limited company engaged in the development of software services and solutions for the education segment, incorporated at 201, Brigade Rubix, 20 Watch Factory Road, Yeshwanthpur, Bangalore – 560 013, called PART A and Srinivas University, a private university located in Mangalore, Karnataka, India (henceforth called the 'University') called PART B. The university was established in 2015 by the A. Shama Rao Foundation through the *Srinivas University Act, 2013*. It is part of the Srinivas Group of Institutions.

XLANZ India P Ltd has developed a Digital Infrastructure called ODIN DEP (Digital Education Platform) using some of the most advanced technologies, combined with several perspectives of data from the Industry and the job market through several hours of research. This platform is cloud hosted and is poised to be the leader provider for digital infrastructure for the education segment in India.

1. Objective The objective of this MOU is to implement a digital infrastructure at the University, using ODIN-Digital Education Platform a digital infrastructure developed and wholly owned by the 'company'. The platform delivers various education and career related services to the students directly and through institutions. The ODIN - DEP 2.0 version supports the following modules and will be implemented for the 'university' as per schedule mentioned in the addendum. The ODIN-DEP is a cloud hosted platform, and is delivered as a service to the 'University' to enable







- a. Better Employability The ODIN-EEP module is aimed at coaching the students remotely to be better prepared for success at competitive exams aimed at securing employment. The Module broadly maps the major employment avenues in the country and maps the competencies that are needed for success in the competitive exams.
- b. Better Admissions The ODIN-CCCS module uses advanced technology to counsel students for admission to the right courses based on the interest and strengths of the aspirant. This module aims to improve the qualitative and quantitative state.
- c. Better Industry Knowledge The ODIN-ICC module allows the students to pick certificate courses of their choice, that better quips them with the current trends in the Industry. These courses are also aimed at cross skilling the students to gain a broad perspective of the Job function.
- d. Deliver classroom augmented sessions & Distance education programs, in a managed approach, thereby allowing the 'University' to capitalize its expenses better, enabling better ROI for the University.

There may be other functionality and services that will be launched from time to time as per production roadmap. These new services will also be covered under the objective and terms of this MOU.

The Objective of the University is to make the EEP course (Employability Enhancement Module) mandatory for all students under courses/colleges under the Srinivas University as a mandatory subject, with the objective of ensuring better employability (includes entrepreneurship) for its graduating students. The EEP as a subject is designed to start from semester 1 and will carry forth till semester 6, with an option of extending it to Semester 7 and Semester 8 for the 4 year courses. The Company has worked out a volume pricing for the EEP module for Srinivas University.

### 2. General Terms of MOU

**2.1 Duration of MOU**: This MOU shall be operational upon signing and will have an initial duration of five years. All activities conducted before this date within the vision of the joint collaboration will be deemed to fall under this MOU.

2.2 Coordination: In order to carry out and fulfill the aims of this agreement, each party will appoint an appropriate person(s) to represent its organization and to coordinate the implementation of activities. The "Company" and "University" staff will on need basis (preferably with one week's notice) to discuss progress and plan activities.

2.3 Technical and Financial: All technical assets and content on the ODIN platform is solely owned by XLANZ India P Ltd.

- ? In case of any joint development or launch of any course, on ODIN, developed by the University, such courses will be covered under separate IP agreements, which will form an addendum to this MOU.
- ? The MOU shall operate under a revenue sharing agreement of 65% to the 'Company' and 35% to the University. The exclusions from this revenue sharing arrangement and the itemized pricing is outlined in the annexure to this MOU.
- ? This MOU acknowledges that the price of the ODIN EEP services will be jointly reviewed and agreed every 24 months.
- ? At the end of every month, a revenue statement shall be generated by XLANZ, and payments will be settled within 30 days from the date of Invoice.

2.4 Confidentiality: Each party agrees that it shall not, at any time, after executing the activities of this MOU, disclose any information in relation to these activities or the affairs of business or method of carrying on the business of the other without consent of both parties.

2.5 Termination of MOU: The partnership covered by this MOU shall terminate upon completion of the agreed upon period. The agreement may also be terminated with a written one month notice from either side. In the event of non-compliance or breach by one of the parties of the agreement, the other party may terminate the agreement with immediate effect.

2.6 Extension of Agreement: The MOU may be extended provided the parties agree upon, and can provide the necessary resources.

3.2 **Alumni** - There is a possibility that students may wish to continue using the account, for a longer period, after their tenure at the college. ODIN allows extended logins for students at a nominal extra fee.

3.3 **Invoicing - A) EEP-** The University will issue a PO to the company mentioning the number of logins in each batch. The company will raise an invoice with the university at the end of the every month based on new logins created (including their serial numbers). **B)** In the case of Admissions (CCCS) module, the University shall furnish to the company the list of students who have been admitted though the platform and the Company shall raise an invoice accordingly. **C)** The Company, shall also provide a list of students who have paid up for ICCC (Industry certified courses) and shall transfer an amount due to the University. The University (or the Company) undertakes to pay the invoices, to the 'Company' (or the University) within 30 days from the date of the invoice

3.4 **Branding & Citation -** Both parties may cite each other's names in promotional literature. However any information that is deemed confidential may not be shared without prior permission in writing.

3.5 **Reports** - ODIN platform shall provide a summary report at the end of each month to the University on student progress and accounts (receivable and payable) 3.6 No Party shall withhold any payments for failure to comply with terms and conditions stipulated in this MOU and subsequent addendums. Such Non-Compliance shall be taken up and resolved in keeping in mind the objective of the program, by a joint committee formed by senior members of both parties, if this does not yield a successful resolution, a arbitration team shall be formed.

3.7 Both Parties shall keep each other informed of any event, which could have a negative influence on or endanger the successful accomplishment of the tasks or Vision described in the lagreement.

3.8 Both parties agree to make payments to each other as per rules and regulations stipulated by Law, this includes payment of all applicable taxes.

3.9 Both parties assume that this agreement does not go against the rules and regulations of the Government of India, and in case any clause is rendered untenable by law, the remaining portions of the MOU will survive.

The terms and provisions in this MOU also apply to any subsequent addendum to this agreement.
