In exercise of the powers conferred by Sections 25(i) and 35(4) of NMC Act, 2019, the approval of PGMEB, NMC is hereby conveyed for grant of **Recognition of MS(Otorhinolaryngology) qualification for 02 seats in respect of students being trained at Srinivas Institute of Medical Sciences & Research Centre, Mangaluru under Rajiv Gandhi University of Health Sciences, Karnataka**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:

3. As per the Assessor's report, there is deficiency of one Assistant Professor. You are directed to take corrective steps to fill up the vacant post and inform the Postgraduate Medical Education Board of NMC within six months from the date of issuance of this letter.
